

TERMS AND CONDITIONS

General Terms

- By participating in the campaign, all participants agree to abide by these Terms & Conditions set herewith by Maldives Airports Company Limited (MACL).
- MACL reserves the right to change any or all of the Terms & Conditions without notice.

Article 1: Subject

- 1.1. Maldives Airports Company Limited (MACL), located in Velana International Airport (VIA), Hulhulé, Republic of Maldives is organizing a campaign from 03rd August – 31th Oct 2022. This campaign is named "Follow Us & Win Your Next Vacation to Maldives".
- 1.2. To qualify for the contest, participants must follow VIA's social media accounts, share the campaign post, and tag three friends in the comments.
- 1.3. The winners will be featured on our social media and will win a grand prize.

Article 2: Conditions of participation

- 2.1. Participation in the contest is free and the participant shall be over the age of 18
- 2.2. Employees of MACL and their immediate family will not be eligible to participate in this campaign.
- 2.3. MACL reserves the right to conduct necessary checks in order to verify the identity of the participant.
- 2.4. Participants who has not completed all the actions required will be disqualified.
- 2.5. Participation in the contest implies that participants accept the integrity of these rules. Non-compliance with these rules results in the automatic cancellation of the participation in the contest and of the candidacy for the prize.

Article 3: Terms of participation

- 3.1. In order to participate in the contest, participants shall follow VIA's social media accounts, share the campaign post, and tag three friends in the comments before 30 September 2022 midnight.
- 3.2. If participants complete all actions on each platform of VIA social media (Facebook, Instagram, and Twitter), it will be considered three entries from the same participant.

Article 4: Selecting the Winner

- 4.1. After the deadline of the contest, three winners will be selected from each platform randomly. Before MACL posts the username and details of the winners on VIA Official social media, the winning participants will be requested for their consent.

- 4.2. If no response is received after 15 business days from the date MACL notify the winner as per 4.1 above, MACL reserves the right to select a new winner and thereby the previous winner will forfeit all rights to the prize.
- 4.3. MACL reserves the right to disqualify any entry that contradicts with article 2.

Article 5: Description of the prize

- 5.1. The Prizes of this contest are as follows;
